THIS IS A LEGAL DOCUMENT: A CONTRACT BETWEEN THE APPLICANT/MEMBER AND PEACH TREE GOLF & COUNTRY CLUB. Initial here _____.

Trial Membership (family golfing membership) – There is no initiation fee for the Preview Membership but there is a \$500 security deposit which is fully refundable with payment of your final statement-Allow 30 days for processing. Monthly dues are **\$99.00**, and there is no food and beverage minimum-spending requirement. Unlimited practice balls for the three months are available for a one-time \$60 charge. The club rules authorize a limited number of Preview Memberships. To the best of my knowledge, the information I have given is correct and accurate, and if any of the statements contained herein prove to be false, the Board of Directors has the right to demand an immediate resignation.

If Applicant’s Proposal for Trial Membership in the Peach Tree Golf and Country Club (“the Club”) is approved, Applicant/Member and the Club, in recognition of the mutual covenants, promises and conditions set forth herein, agree as follows:

- a. The Preview Membership is a consecutive 3-month term: **January-February- March- April-May-June-July-August-September-October-Nov-Dec (circle 3)**. A Preview Member is legally obligated to the Dues payment for no less than 3 month’s unless the Preview Member transfers to a proprietary Member of Peach Tree (Club). Only in the case of this transfer will the Preview Member be held not liable for the 3 months of dues commitment. Any early termination is in violation of this binding agreement and will result in the forfeiture of the deposit, any additional monies due based on charges accrued and any uncollected dues for the remainder of the agreed upon term and all legal remedies to collect such monies including the agreements held in the binding arbitration agreement held within this agreement.
- b. **Applicant/Member agrees to be bound by the current Rules, Regulations and Bylaws of the Club as they may be properly revised from time-to-time. _____ Initial here**
- c. This Preview Membership shall automatically terminate on final day of the month identified in the period selected/final month. Any deposit owed to the Preview Member shall be paid by the Club upon Preview Members final payment of the balance due from the final month of the agreement. Allow 30 days for processing and mailing of the refundable deposit. _____ **Initial here**
- d. This contract may not be assigned to any other person or entity.
- e. IN THE EVENT OF ANY CONTROVERSY, CLAIM OR DISPUTE BETWEEN A PREVIEW MEMBER OR THE MEMBER’S FAMILY OR GUESTS AND THE CLUB, WHICH CLAIM OR DISPUTE IS NOT RESOLVED INFORMALLY BY

Proposal for Preview Membership

THE PREVIEW MEMBER AND THE CLUB, THE MATTER SHALL BE SUBMITTED TO AND DECIDED BY NEUTRAL, FINAL AND BINDING ARBITRATION IN ACCORDANCE WITH THE CALIFORNIA ARBITRATION ACT, CODE OF CIVIL PROCEDURE 1280 et seq., AND NOT DECIDED BY COURT ACTION, EXCEPT AS PROVIDED BY CALIFORNIA LAW FOR JUDICIAL REVIEW OF ARBITRATION PROCEEDINGS. ARBITRATION SHALL BE THE EXCLUSIVE REMEDY. THE PREVIEW MEMBER AND THE CLUB EACH WAIVE ANY RIGHTS THEY MAY POSSESS TO HAVE SUCH CONTROVERSIES, CLAIMS OR DISPUTES LITIGATED IN A COURT ACTION OR JURY TRIAL. ALL OF THE PROVISIONS OF CODE OF CIVIL PROCEDURE 1283.05, AS WELL AS ANY AMENDMENTS OR REVISIONS THERETO, ARE INCORPORATED HEREIN. THE ARBITRATION SHALL BE CONDUCTED BEFORE AN ARBITRATOR SELECTED BY CLUB PURSUANT TO THE THEN APPLICABLE ARBITRATION RULES. THE ARBITRATOR SHALL HAVE NO AUTHORITY TO AWARD PUNITIVE OR OTHER DAMAGES NOT MEASURED BY THE PREVAILING PARTY'S ACTUAL DAMAGES. JUDGMENT UPON THE AWARD RENDERED BY THE ARBITRATOR MAY BE ENTERED IN ANY COURT HAVING JURISDICTION. EXCEPT AS MAY BE NECESSARY TO ENFORCE THE AWARD, NEITHER THE PREVIEW MEMBER NOR THE CLUB MAY DISCLOSE THE EXISTENCE, CONTENT OR RESULTS OF ANY ARBITRATION WITHOUT THE PRIOR WRITTEN CONSENT OF ALL OTHER PARTIES TO THE ARBITRATION.

- f. In any litigation, arbitration or any other proceeding where a party to this Agreement seeks a declaration of their rights and obligations, or to enforce the provisions of this Agreement, the prevailing party shall be awarded reasonable attorney fees, together with any costs and expenses incurred to resolve the dispute and to enforce the provision.
